

FREQUENTLY ASKED QUESTIONS (FAQs) (Financial Literacy Quiz - 2022)

- 1) What is the Quiz called?
Answer: - The Contest is called “Financial Literacy Quiz”

- 2) Who is conducting Quiz?
Answer: - National Centre for Financial Education (NCFE) is conducting the quiz in coordination with financial sector regulators viz. RBI, SEBI, IRDAI and PFRDA.

- 3) What is the objective of the Quiz?
Answer: - To make college students / youth aware of basic financial literacy and increase financial education amongst them.

- 4) Is there any fee for participating in this Quiz?
Answer: - No, participation is free of cost.

- 5) Who can participate in Quiz?
Answer: The students who have currently enrolled in recognized University / college / Institution in India. CA / CS / CMA and equivalent professional courses pursuing students are eligible to apply. The participant should have completed their higher secondary (10+2) or equivalent educational level and currently studying in any Institution / college / University in India.

- 6) When the registration for Quiz will start and be conducted?
Answer: - The registration for the quiz will open from 01 February, 2022 (09:00 AM), and will close on 18th February, 2022, 04:00 PM. Quiz will be conducted from 14th February, 2022 (09:00 AM), to 18th February, 2022, 05:00 PM.

- 7) What is the procedure for registration?
Answer:
 - Visit <https://apply.registernow.in/ncfe/registration/>
 - Fill all the details correctly as requested in the application form.
 - Upload the required documents.
 - Provide the username of NCFE’s E-LMS. (Register for NCFE’s E-LMS at <https://ncfearthashiksha.in/>)
 - Re-verify all the details before final submission.

- 8) What documents need to be uploaded along with the Registration Form?
Answer: - Scanned images of candidate’s passport size photograph and ID card issued by educational institute are to be uploaded with the Application Form.

- 9) What is the mode of Quiz?
Answer: - Online Mode.

- 10) Whether active email address / mobile number is required for registering for the quiz?

Answer: - Yes, Participant has to provide email address and mobile number. All communications regarding quiz will be sent on registered e-mail ID / mobile Number only.

11) What can be referred for the Quiz?

Answer: NCFE's E-LMS (available at <https://ncfearthashiksha.in/>) course material can be referred. However, NCFE reserves the right to ask any questions related to financial literacy and awareness.

12) What is the pattern of the quiz?

Answer:

- Quiz duration is **10** minutes.
- No. of questions in quiz is **40**.
- Questions will be of Multiple Choice / Objective type.
- No negative marking.

13) Can I move back and forth between the questions?

Answer: - Yes, candidates will have the option to navigate between the questions by following instructions available on the User Interface. They may change even answer options, any time before they click the 'SUBMIT' button.
